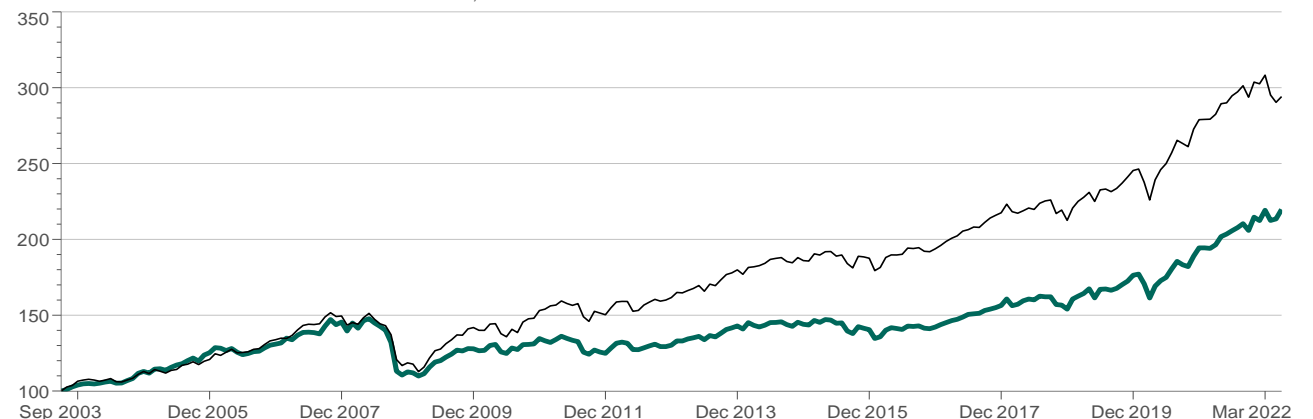

October 2003 - March 2022 (Single Computation)

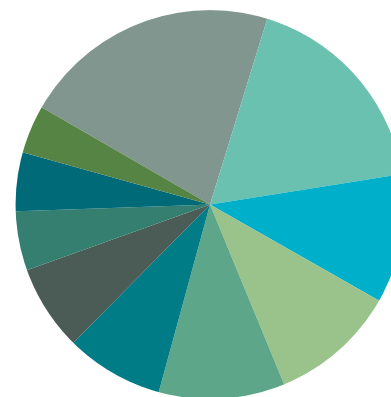

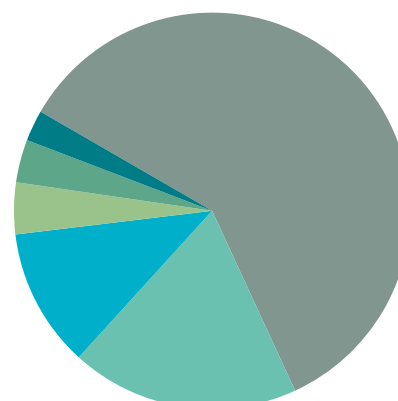
