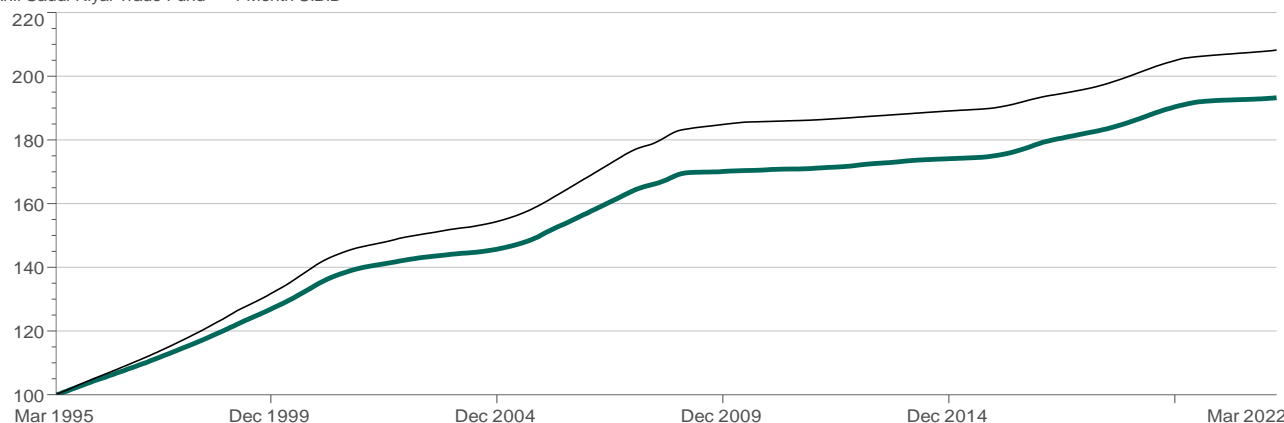

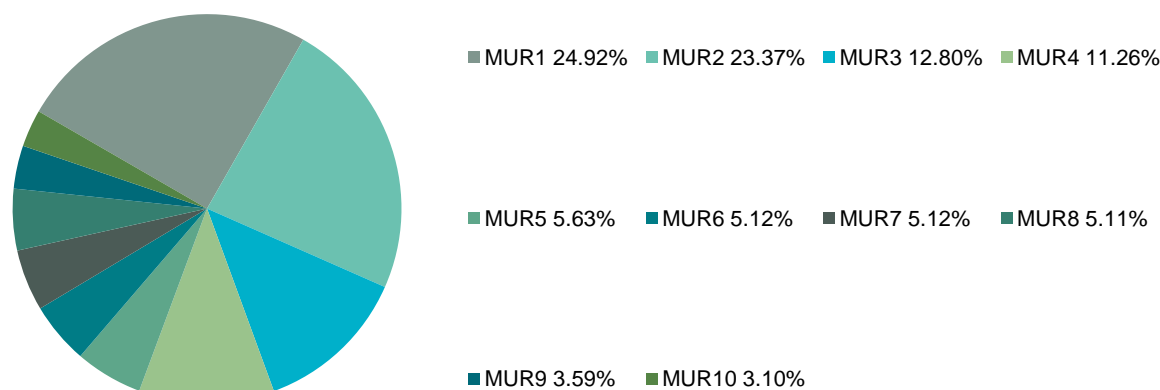
Manager Performance
