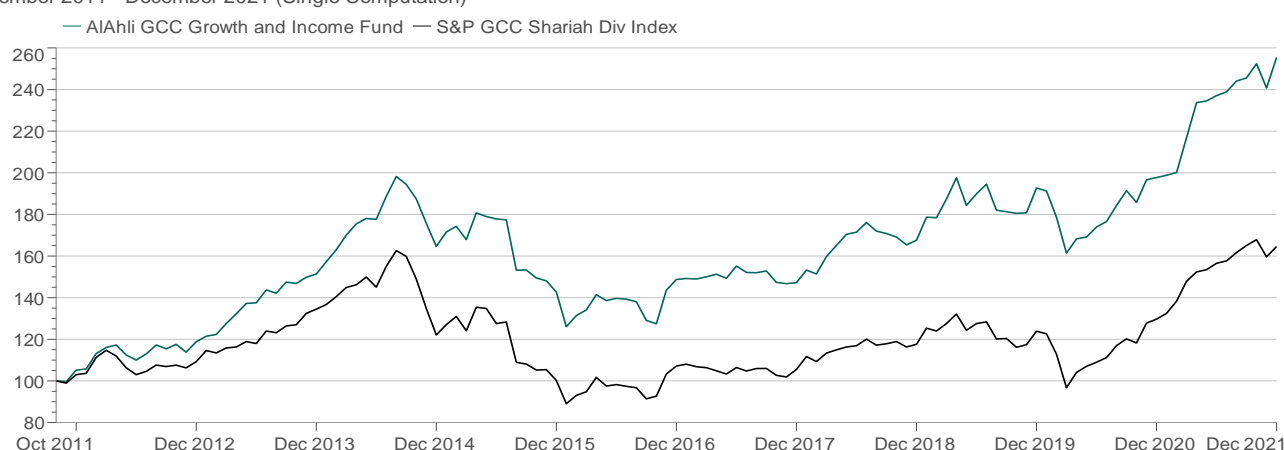

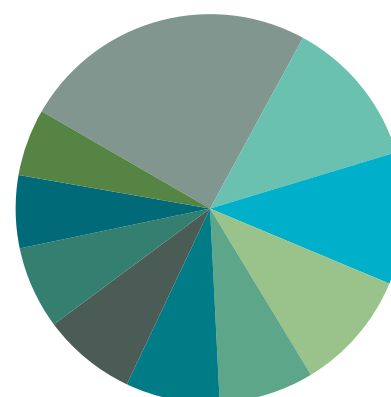
November 2011 - December 2021 (Single Computation)

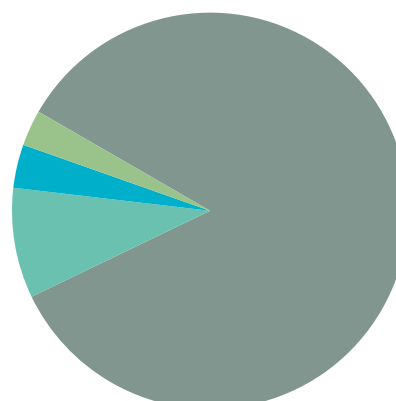
