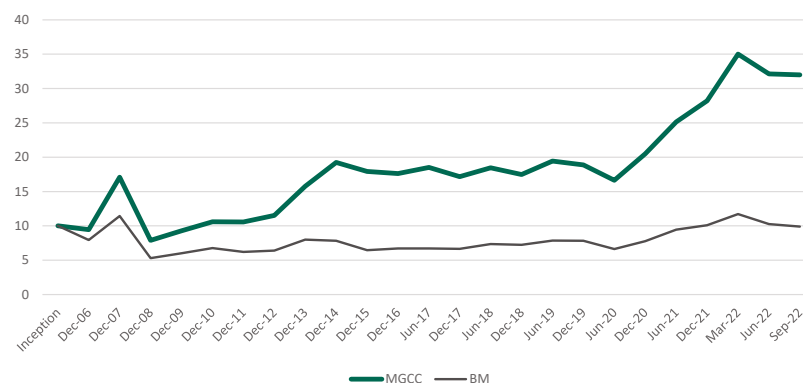

Manager Performance

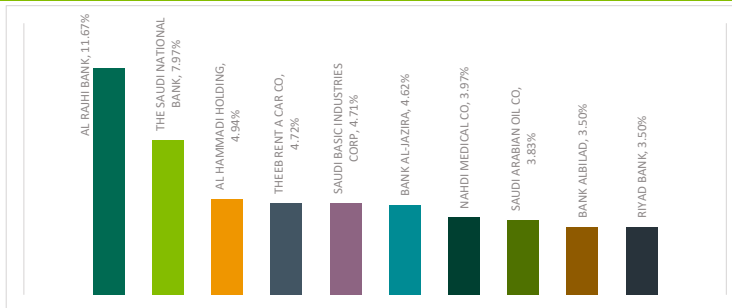
