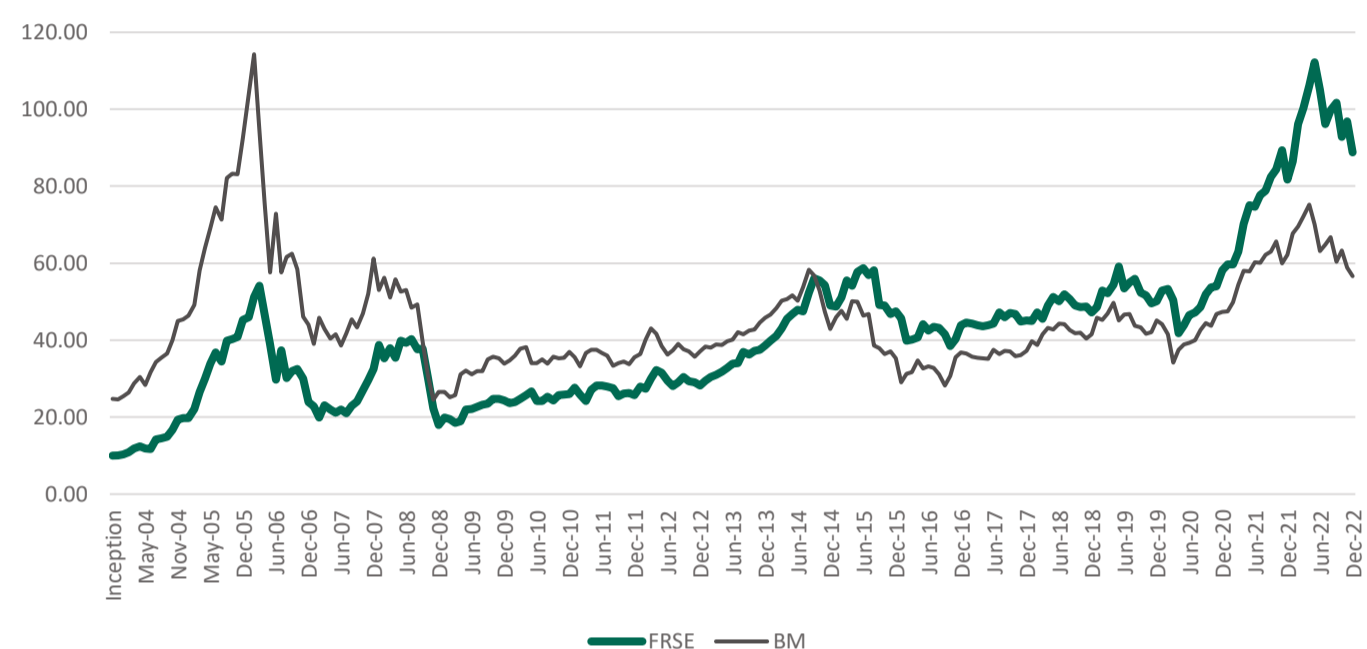

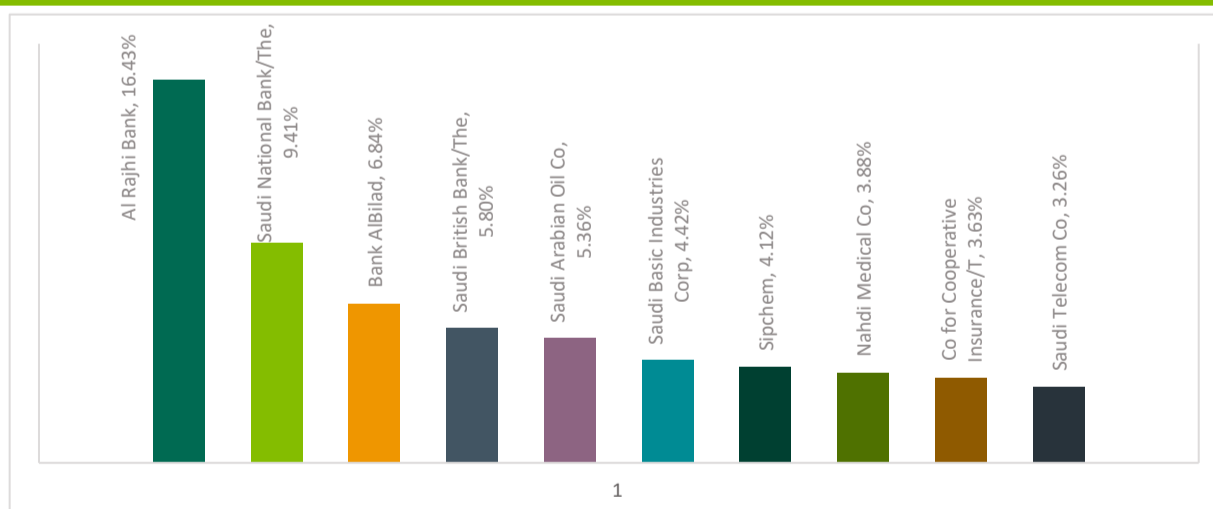
December 2003 - December 2022 (Single Computation)



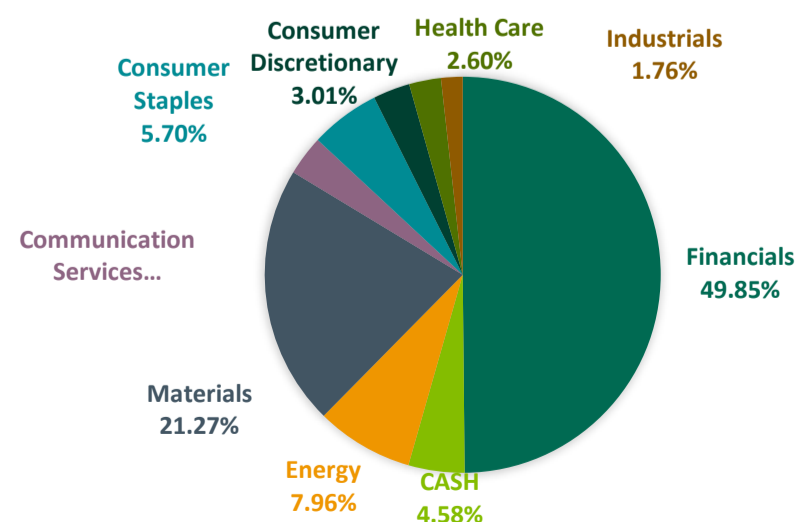
