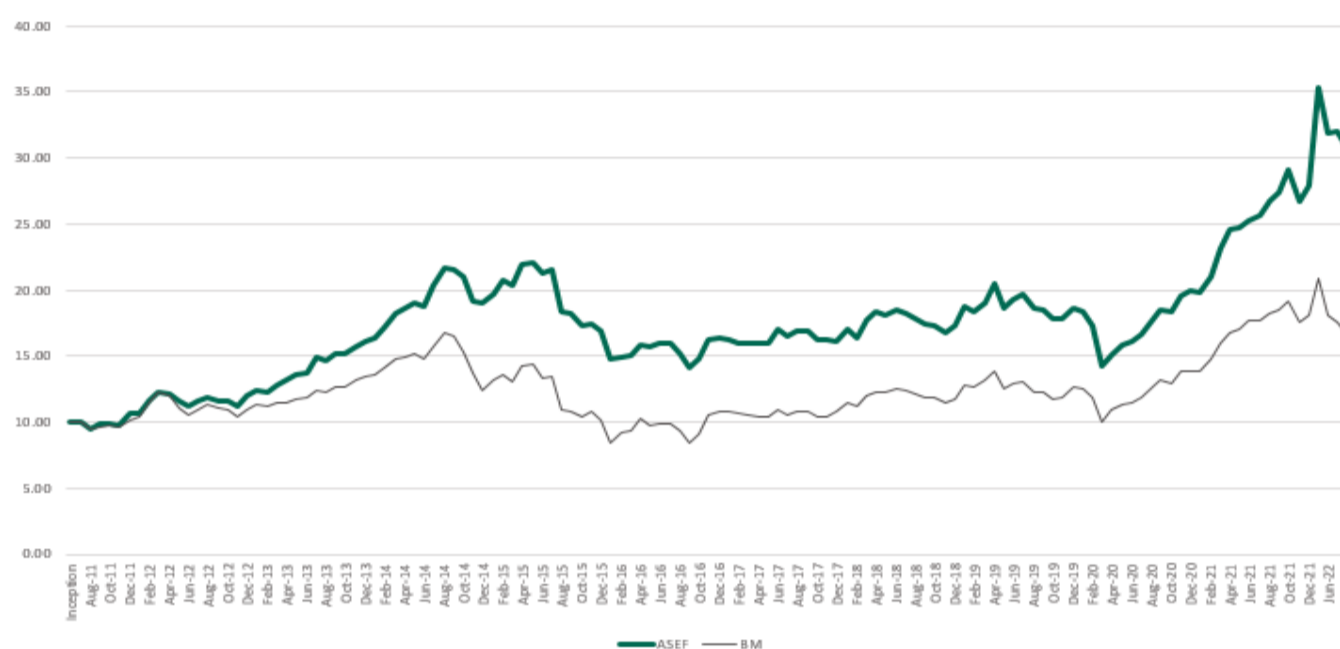

### Manager Performance

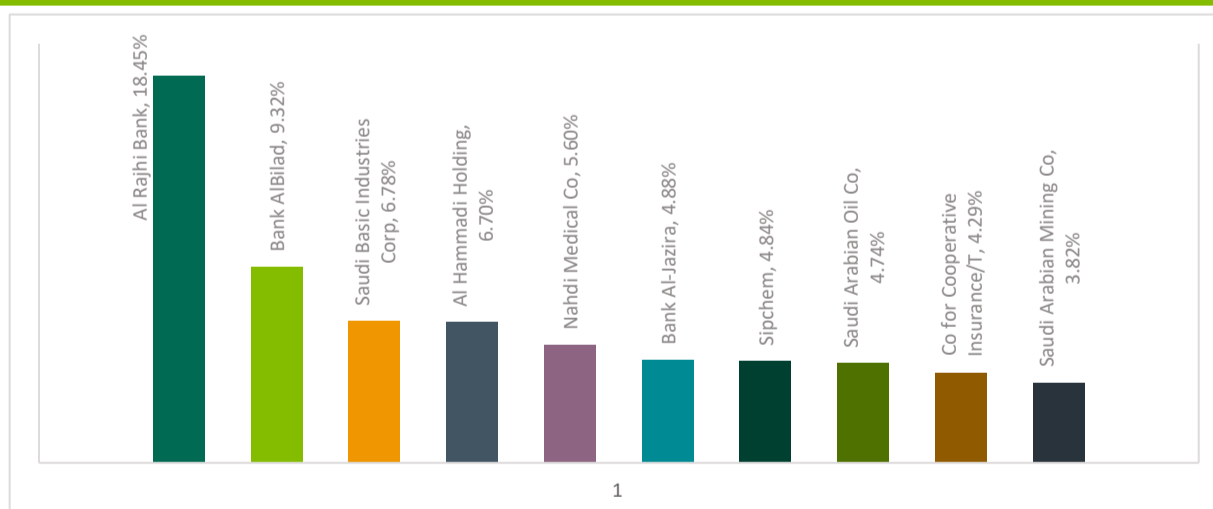
July 2011 - December 2022 (Single Computation)



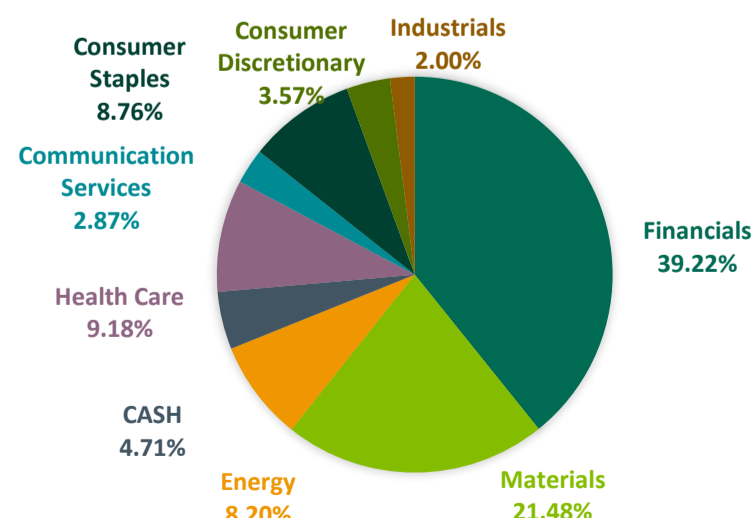
