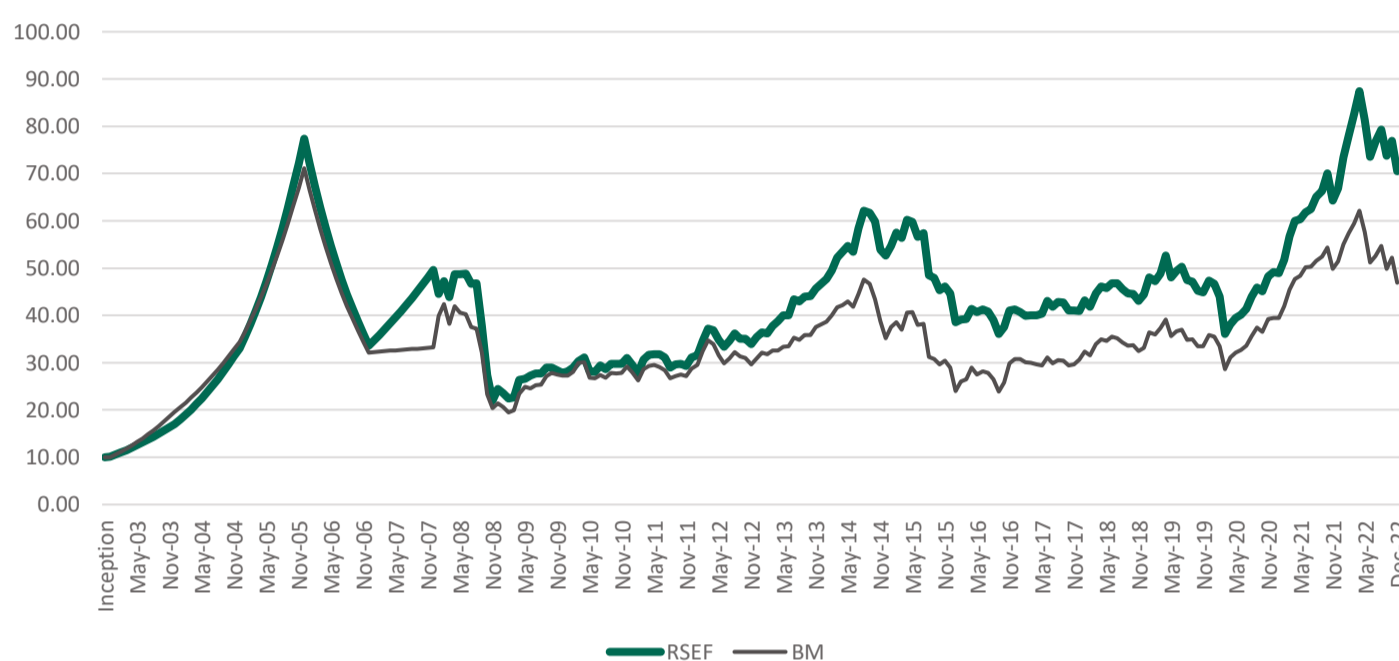

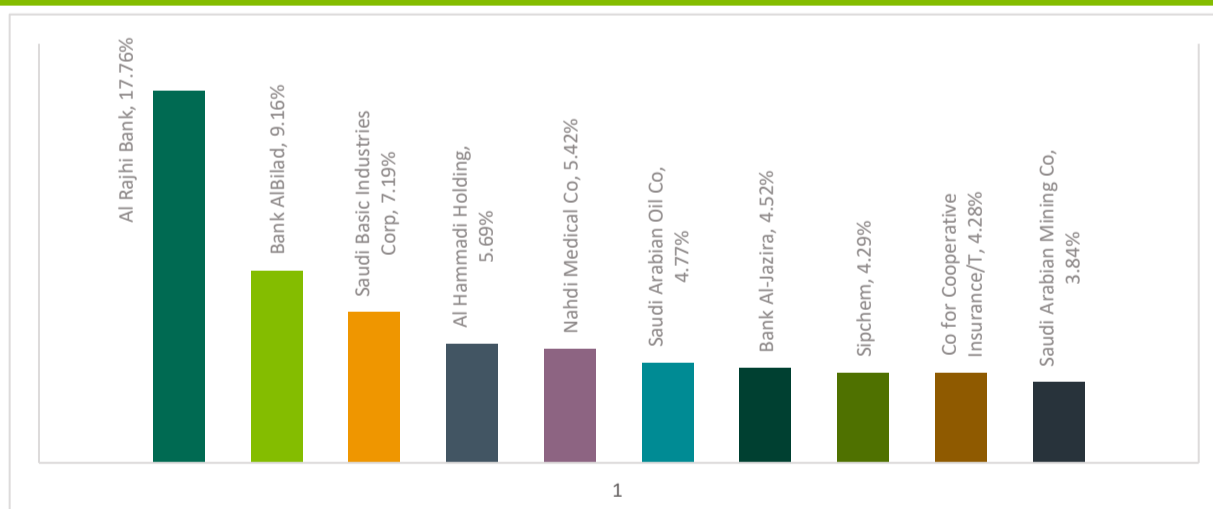
December 2002 - December 2022 (Single Computation)



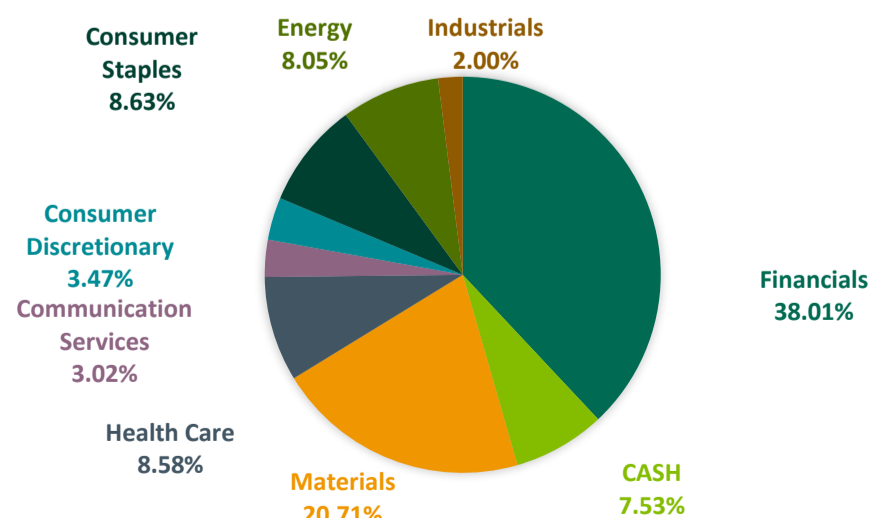
