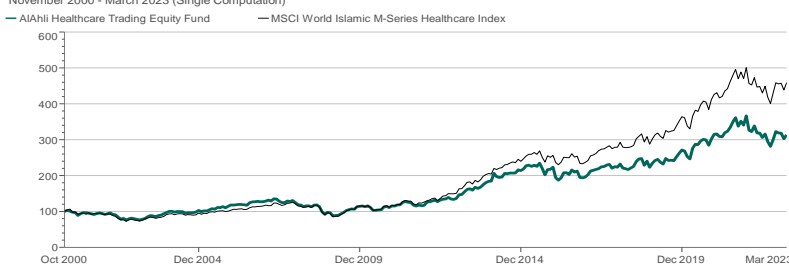

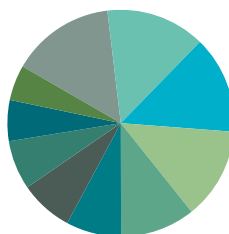
November 2000 - March 2023 (Single Computation)

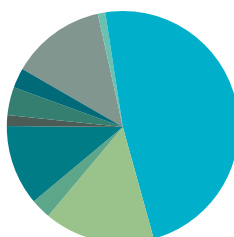
