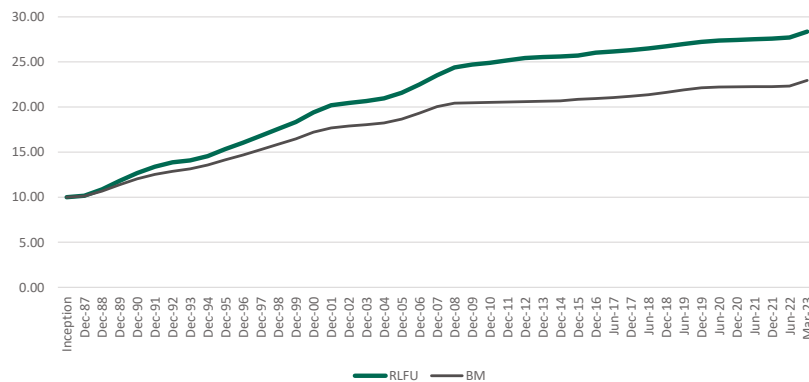

### Manager Performance

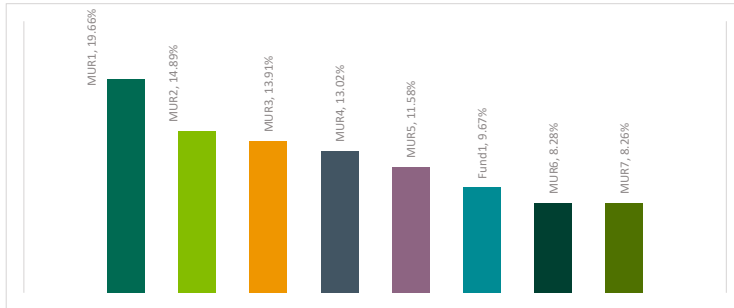
September 1987 - March 2023 (Single Computation)
