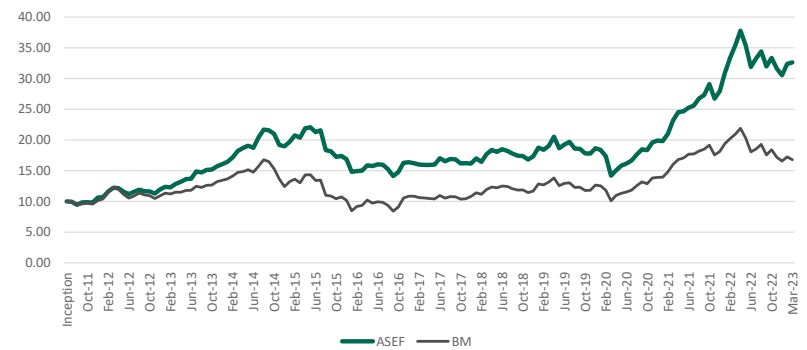

### Manager Performance

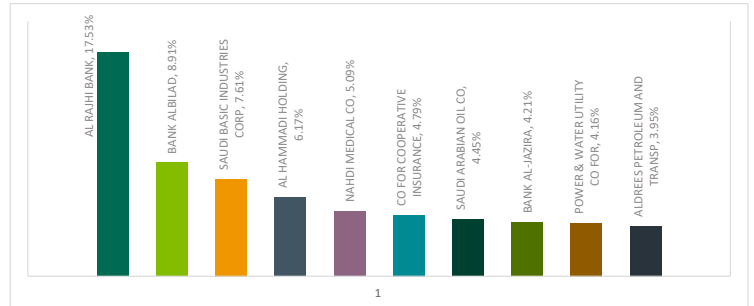
July 2011 - March 2023 (Single Computation)
