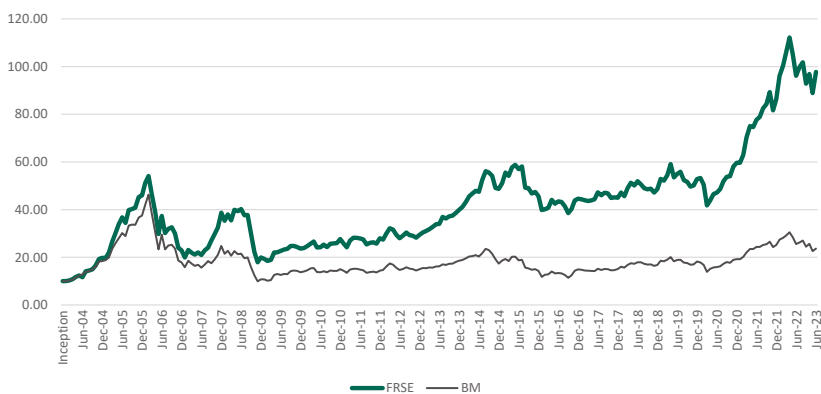

### Manager Performance

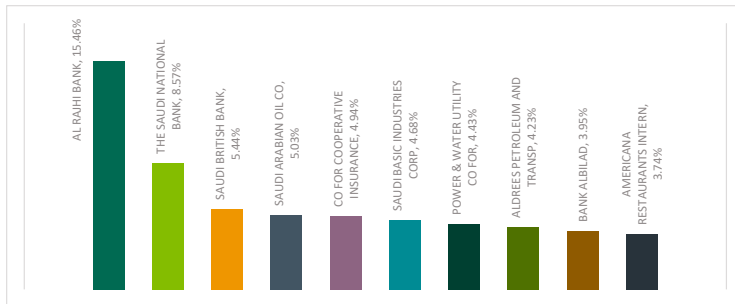
December 2003 - June 2023 (Single Computation)
