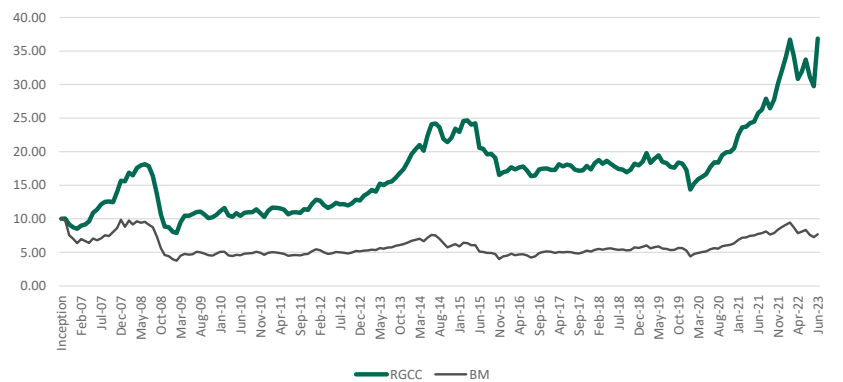

### Manager Performance

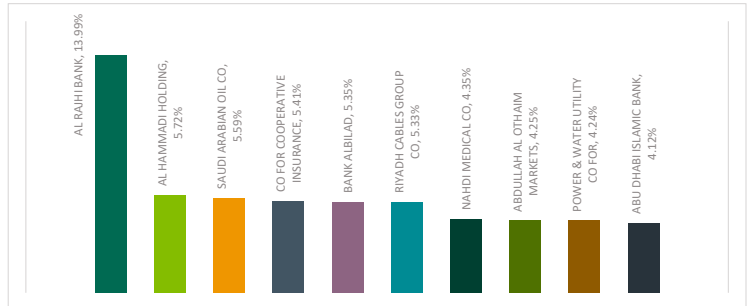
October 2006 - June 2023 (Single Computation)
