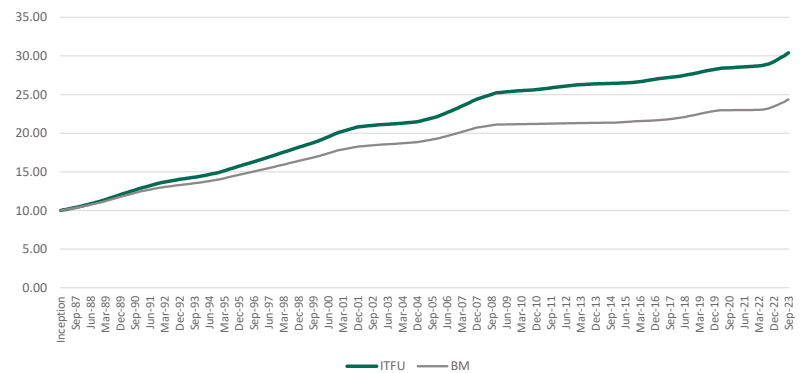

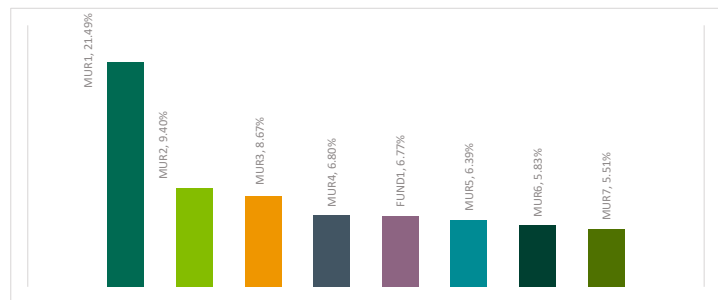
December 1986 - September 2023 (Single Computation)
