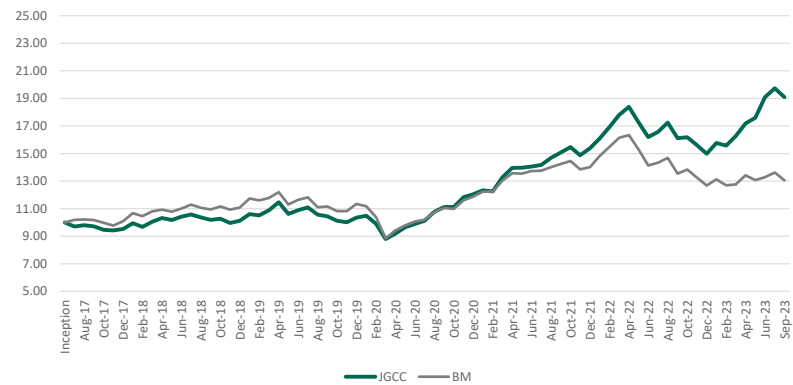

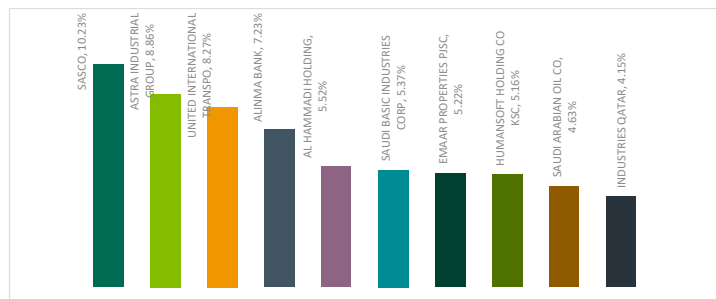
July 2017 - September 2023 (Single Computation)
