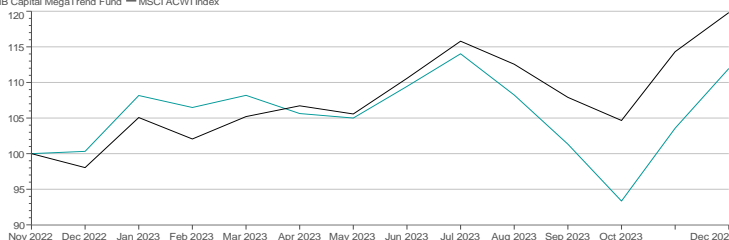

December 2022 - December 2023 (Single Computation)

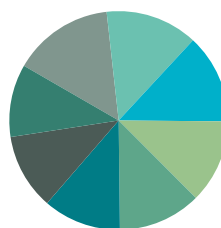

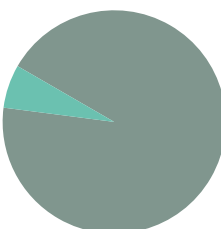
