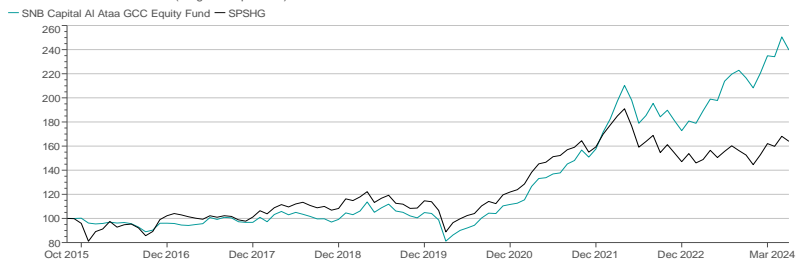

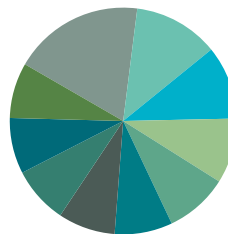
Manager Performance

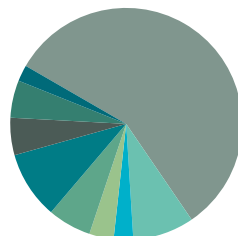
