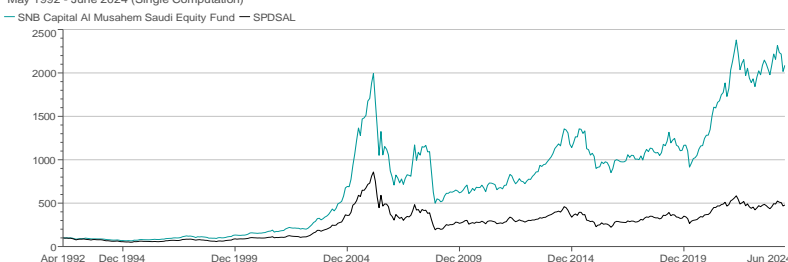

May 1992 - June 2024 (Single Computation)



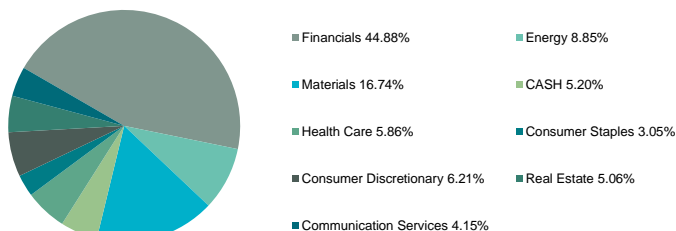
