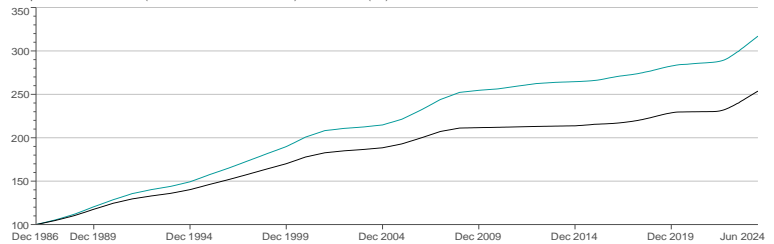

January 1987 - June 2024 (Single Computation)

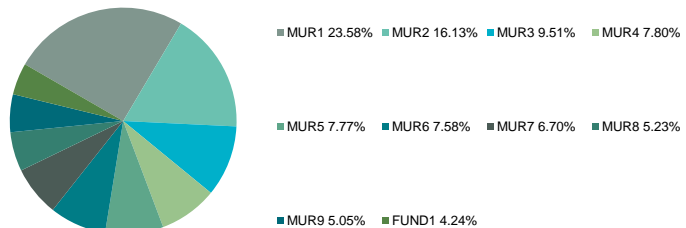
